Your application to train veterans and eligible persons at International American University, 3440 Wilshire Blvd. Suite 1000, Los Angeles, CA 90010, under Title 38 U.S. Code, is approved by the California State Approving Agency for Veterans Education (CSAAVE), a division of the California Department of Veterans Affairs.
